### Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

CHIME engaged in multiple opportunities for parents, teachers, and staff to provide feedback regarding the development of the Expanded Learning Opportunities Grant Plan. Parents were engaged in monthly CHIME Community Association meetings and Coffee with the Principal meetings. These meetings provided opportunities to provide feedback on what was effective in CHIME's current outreach and learning enhancement strategies this school years and what would be needed in the future. Parent representatives on the Director's Leadership Advisory committee also were able to give feedback and input into the creation of the plan. Similarly, staff was afforded a wide range of feedback opportunities including monthly staff meetings, Teacher's Leadership Committee, the Multi-tiered Systems of Support Committee and staff division meetings at which they could give input as to the best use of the Expanded Learning grant funding. Feedback from all stakeholders combined with a review of the student needs helped to inform the development of this Expanded Learning Plan.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified using a number of tools including our special education information system, our Engagement tracking records from the 20-21 school year, assessment data from the spring SBAC administration, ELPAC assessment data, attendance records, CalPads data regarding our unduplicated pupil count information and informal classroom assessments. These tools will help us determine which students are most in need of interventions and supports made possible through these grant funds. In the 21-22 school year students will receive baseline assessment and periodic monitoring using classroom-based assessments as well as our verified data assessment system. Students on going need for intervention will be monitored as well as the students' response to the interventions and supports provided by this grant plan.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

CHIME's plan will be comprised of three components for intervention and support. The first will be additional adult supports (both academic and social-emotional) integrated into the classrooms throughout the day. The second will be academic tutoring offered after school hours to support the learning needs of students. Third will be an expansion of our reading and math intervention labs that occur both before and after school and also remotely. Information about these efforts and how families can ensure their children can access these supports will be communicated during our "Back to School" information activities and mailings, via our online parent communication portal (Parent Square), through our public announcements during CHIME Community Association meetings, and via teacher lead communications to families.

A description of the LEA's plan to provide supplemental instruction and support.

1. Additional Adult Supports in the Classroom: additional paraprofessional and other classified staff supports will be added to the classroom in order to support the academic and social emotional needs of students through our academic curriculum as well as our social emotional learning programs. These adult supports will lower the overall adult to student ratio and provide students with the needed access to remediation and intervention necessary to overcome any learning or SEL gaps that have developed during school closure and distance learning.
2. After school academic support: staff will be dedicated to offering tutoring support to students after school hours both via online methods and in person. These supports will help student continue to make academic progress in their 21-22 school year curriculum while remediating and areas of weakness in their academic skills.
3. Expansion of Reading Lab and Math Lab interventions: CHIME will increase the number of available seats for the Reading and Math intervention labs which occur before and after school hours. These interventions target students who have identified gaps in their reading and math skills. In anticipation of increase need, CHIME will utilize grant resources to expand the number of students who can be accommodated in these programs.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The core strategies that CHIME has chosen for our Expanded Learning Opportunities Grant Plan – additional adult support in the classrooms, expanded one on one and small group tutoring opportunities, and expanded intervention programming – are echoed in the usage plans for other ESSER II funds received by the school. By coordinating the expenditures of the ESSR II funds toward the same types of supports as our Expanded Learning Grant funds we will be able to achieve a duration of interventions and supports across the school year as well as an intensity of remediation for students in need.

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). ## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
