CHIME engaged in multiple opportunities for parents, students, teachers, and staff to provide feedback regarding the development of the ESSER III plan. Parents were engaged in monthly CHIME Community Association meetings and Coffee with the Principal meetings as well as Parent Q and A events throughout August, September and October. These meetings provided opportunities to provide feedback on what was effective in CHIME's current safe in person learning strategies and learning recoupment strategies this school year and what would be needed in the future. Student feedback was secured through Student Council and student surveys. Parent and teacher representatives on the Diversity by Design committee and CHIME Community Committee also were able to give feedback and input into the creation of the plan.

Similarly, staff, teachers and administration were afforded a wide range of feedback opportunities including monthly staff meetings, Teacher's Leadership Committee, the Multi-tiered Systems of Support Committee and staff division meetings at which they could give input as to the best use of the ESSER III grant funding. In additional the needs of students with disabilities, English Learners, foster and homeless youth, and other underserved youth were also considered through collaboration and discussion with our

university partner California State University, Northridge and their College of Education as well as our mental health partner the Mitchell Family Counselling Clinic. Feedback from all stakeholders combined with a review of the student needs helped to inform the development of this ESSER III Plan.

Families that speak languages other than English were engaged in similar outreach efforts described above and in addition written communication about the needs assessment processes for the ESSER III was provided to families through Parent Square in English and in Spanish. In addition, this parent communication software utilizes technology to receive translated communication in a language of their choice other than English or Spanish and over 50 languages are available.

Special Education administrators and staff were meaningfully engaged in the planning process through weekly discussion and collaboration regarding the needs assessment process for ESSER III plan during weekly special education department meetings.

#### A description of how the development of the plan was influenced by community input.

The feedback from these stakeholders influenced the plan in that priorities were identified in the area of mitigation strategies for COVID-19 spread, additional classroom supports to increase the intensity of instruction and remediation for of student learning loss and intervention software to address learning gaps for students.

The nearest tribal land to CHIME's campus is over 75 miles away. Out of our approximately 730 students, five identify as American Indian. These families were included in all prior family engagement efforts identified in this section and in that way outreach efforts were made to include their input; however, our school does not serve a population with significant representation from a tribe nor does it reside on area within tribal land.
